The applicant must fulfill the following conditions:

1. Out of five posts, one post shall be reserved for the candidate with disability who shall be adjusted against the post of the category to which he/she belongs.
2. A Post Graduate Degree in Homoeopathy from recognized University/Statutory State Board/Council recognized under the Homoeopathic Central Council Act, 1973 (59 of 1973).
3. Candidate must be enrolled on the State Register or Central Register of Homoeopathy.
4. These posts are tenure posts for a maximum period of three years.
5. The maximum age limit of applicant shall not exceed 40 years, as on the last date of receipt of application as per general rules of Government. (Maximum age limit is 43 years in case of Other Backward Classes).
6. The Selection will be made on the basis of written examination followed by Interview of the selected candidates. The date of written examination will be informed to all the applicants later on through E-mail and website www.shmch.delhigovt.nic.in
