ADDENDUM

In partial modification of the Notice published on 10.11.2019 for the recruitment of Senior Residents (Homoeopathy), the number of posts of **Senior Residents (Homoeopathy)** for the various categories shall now be as under:

Dr. B. R. Sur Homoeopathic Medical College & Hospital (1 UR, 1 OBC, 1 SC)
Nehru Homoeopathic Medical College & Hospital (2 UR)

1. Candidates must send their applications through email at principal_shmc@yahoo.com latest by **27th August 2020(11.59PM)**. The proforma of application is available on the website <http://shmch.delhigovt.nic.in>
1. Now, there will not be any written examination. Selection will be made on the basis of merit-cum-performance in the interview scheduled to be held from **28th August to 30th August 2020**.
2. Candidates who have already applied and have been declared provisionally eligible need not to apply again. (list available on <http://shmch.delhigovt.nic.in>).
3. List of candidates who were then not found eligible is also available on <http://shmch.delhigovt.nic.in> and they may apply fresh if they consider themselves eligible by the above stated date.
4. Eligibility criteria and other terms and conditions shall remain the same as in notice dated 10.11.2019 and are available on <http://shmch.delhigovt.nic.in>
5. **In addition, 08 "Research Associates" (4 UR, 2 EWS, 1 SC, 1 OBC) (number of posts may vary) shall be engaged in Dte. of AYUSH, Delhi on contract basis for six months on a consolidated remuneration of Rs.47,000/-+HRA per month from the waitlist panel of Senior Residents; no separate advertisement shall be issued in this regard. The qualification of these posts shall be the same as for Senior Residents (Homoeopathy).**
6. Out of 02 posts of Senior Residents (Homoeopathy) at Nehru Homoeopathic Medical College, 01 (One) post shall be reserved for the candidate with benchmark disability (PwD) who shall be adjusted against the post of the category to which he/she belongs.
7. Any eligible candidate of EWS category, who has already applied for the post of Senior Resident (Homoeopathy) under UR (Unreserved) category in response to Advertisement Notice dated 10.11.2019 and have been declared provisionally eligible as per list available on <http://shmch.delhigovt.nic.in>, shall submit their valid EWS category certificate issued by the Competent Authority for consideration of their candidature for the posts of Research Associates in Dte. of AYUSH, Delhi as advertised vide addendum dated 20/08/2020. A copy of the certificate shall be submitted through email to principal_shmc@yahoo.com latest by **27th August 2020(11.59PM)**.
