Terms and Conditions of Contractual Appointment

1. The amount of monthly consolidated remuneration/fee shall be Last Pay minus Basic Pension plus DA at the applicable rates. However, he/she shall continue to draw pension and dearness relief thereon during the period of his/her engagement as Professor/Consultant. His/her engagement as Professor/Consultant shall not be considered as a case of re-employment.
2. He/She shall not be entitled to any allowances, financial benefits or concessions such as House Rent Allowance, Reimbursement of call charges of residential telephone/mobile, Transport Facility, Residential Accommodation, Personal Staff, etc.
3. Age: Candidates should not be more than 69 years of age on the last date of receipt of applications.
4. These posts are to be filled purely on contract basis. The engagement of Professor/Consultant is of a temporary nature and the engagement can be cancelled at any time by the Department without assigning any reason.
5. The engagement of Professor/Consultant would be for one year or till the regular appointment is made by the Department, whichever is earlier.
6. The engagement of Professor/Consultant would be on a full-time basis and they would not be permitted to take up any other assignment during the period of consultancy.
7. No Government vehicle shall be provided to the Professor/Consultant.
8. No TA/DA shall be admissible for joining the assignment or on its completion. He/She will not be allowed foreign travel at Government expenses. However, He/She shall be allowed TA/DA for his/her travel inside the country in connection with the official work, if any, as per their entitlement as on the date of retirement.
9. He/She shall be eligible for 8 days leave in a calendar year on pro-rata basis. Therefore, he/she shall not draw any remuneration in case his/her absence beyond 8 days in a year (calculated on pro-rata basis). Also unavailed leave in a calendar year cannot be carried forward to next calendar year.
10. If he/she neither accepts nor seeks time to accept the offer within the prescribed limit of 7 days, the appointment shall be offered to the next on the waiting list.
11. Since engagement of Professor/Consultant is against a vacant post of a particular Institute, request for transfer to another Institute shall not be considered.
12. The candidate must be registered with MCI/State Council/Board/CCH before appointment to the Post.
